What if tech companies and social media platforms realized that providing a safe internet for children to learn and thrive was more important than turning a blind eye to sexual abuse and exploitation in order to maximize corporate profits?

We are committed to not just addressing the symptoms of exploitation, but confronting its root causes, challenging the institutions that profit from it, and transforming societal norms to bring about its demise. To do so will require a mass-scale prevention effort, which if successful, will make such a world a reality by creating a firewall that will protect every individual from the potential of being sexually abused and exploited – ensuring the damage never occurs in the first place!

With your support, this past year saw great progress! Our legal, corporate, and policy efforts are creating a firewall! Now is the time to accelerate that momentum.

Under the banner of "Radiating Hope, Catalyzing Change," we call upon each one of us to be part of this crucial fight to create a world free from sexual abuse and exploitation. Together, we can make this transformative change a reality.

CORE OBJECTIVE DRIVING SOCIETAL CHANGE TO REJECT PORNOGRAPHY

Pornography fuels many forms of sexual abuse, violence, and exploitation. If we are to stop the damage of sexual exploitation before it starts, we must make pornography intolerable in society.

VICTORIES AND HIGHLIGHTS:

• THE LAW CENTER'S LAWSUIT AGAINST PORNHUB IN ALABAMA for monetizing the rape of a child IS MOVING ON! Our 2nd case against Pornhub for exploiting a women's field hockey team made it to fact discovery. These are precedent-setting cases already as the courts have rejected Pornhub's motions to dismiss under CDA Section 230.

• GOOGLE now automatically blurs sexually explicit images for ALL USERS! 5.3 billion Google searches per day made safe!

• LOUISIANA, UTAH, VIRGINIA, AND MONTANA PASSED

LEGISLATION requiring verification that a user is over the age of 18 before they can access Pornhub and other sites hosting pornography. **Rather than comply with the law, Pornhub has chosen to ban all users from its site in these states.**

• PORNHUB has been permanently banned from Instagram, TikTok, and YouTube! They had 13 million followers on Instagram, many of them kids. Now, Pornhub has almost no mainstream distribution partners left!

Pornhub receives 2.6 billion monthly visitors—more than Amazon and Netflix combined! Pornhub is the second most trafficked pornography site in the world, following closely after XVideos (whom we are suing as well), and has become the most mainstream. Bringing them down is a **serious blow to the pornography industry**, and sends a message to other mainstream pornography sites **THAT THEY WILL BE NEXT!**

SECURING JUSTICE WHILE HOLDING PORNHUB H1401 ACCOUNTABLE

Imagine the humiliation of knowing the most traumatic moment of your life has been recorded and publicized. Worse still, imagine knowing it has been viewed thousands of times by twisted people who derive sexual pleasure from your suffering.

ple et For Plaintiff Jane Doe #1, this nightmare is her reality.

Jane Doe #1 was just 16 years old when she was drugged and raped by an adult male. The perpetrator filmed the rape and monetized it sthe through Pornhub's official "Modelhub" program. Under the terms of that program, Pornhub and Jane Doe #1's rapist agreed to share profits from views and downloads of Jane Doe #1's victimization-of which there were many. One video was viewed over 2,400 times.


> Pornhub reviewed, categorized, tagged, and disseminated the videos depicting the rape and child sexual abuse of sixteen-year-old Jane Doe #1. At no point did they attempt to verify her age or consent.

> This is wholly unacceptable-and we will not stand for it. Together, we are holding Pornhub accountable and obtaining justice for Jane Doe #1!

CORE OBJECTIVE ENSURE TECHNOLOGY PRIORITIZES CHILD PROTECTION OVER PROFIT

The internet, which presently is rife with landmines resulting in short and long-term damage to children's well-being, can instead be transformed into a place where children can learn and thrive. For this to happen, we will need a concerted effort by activists, parents, and tech experts who will convince and, if needed, take legal and policy actions to ensure tech prioritizes safety and privacy over profit.

VICTORIES AND HIGHLIGHTS:

• THE 2023 DIRTY DOZEN LIST is the most successful year yet! Eight of our targets made significant improvements within just a few months! Upon finding out about their impending inclusion, Apple reached out to be not to be added. We kept them on and they've done much to be excluded next year! Will it be enough?

• **SNAPCHAT** improved detection and removal of sexually explicit/exploitative content: **90% of young people in 20+ countries protected!**

• **DISCORD** activated higher safety settings by default and improves policies on child sexualization: **25% of American children 11-12 years old are protected!**

• **APPLE**, with the iOS17 update, now automatically blurs images and videos containing nudity for kids 12 and under in iMessage, FaceTime, Air Drop, and Photos picker. Considering that 87% of US teens own an iPhone and 88% expect an iPhone to be their next phone, the impact of this win is undoubtedly enormous. Additionally, Apple has already made their blurring technology available to other apps for free through API (application programming interface)! What this means is that **apps accessed through iOS could apply the nudity blurring feature to their platform.**

• KIK, the app which a convicted child molester called "a predator's paradise," implemented almost all of NCOSE's recommendations. This includes making the platform 18+, requiring email verification to create accounts, using bots to monitor livestreams for nudity and inappropriate comments, creating an option to block direct messages from strangers, and drastically limited the amount of sexually explicit content. Prior to changing the age of the platform, Kik was used by 1/3 of American teens, and 70% of their users were 13 – 24 years old.

• The NCOSE Law Center is part of a class action lawsuit against Meta (Facebook), Snap, Roblox, and Discord for targeting minors and allowing their platforms to be used for sex trafficking.

• **CONGRESS** introduced several bills to **force Big Tech and social media companies to take action to protect children on the internet.** These bills have passed out of committee with dozens of co-sponsors on both sides of the aisle! We brought 280+ leaders to advocate for these bills directly with legislators, prompting the Senate Judiciary to call five Big Tech CEOs to appear before them in early 2024!

• THE INTERNATIONAL CENTRE ON SEXUAL EXPLOITATION (ICOSE) drafted model legislation for the Organization for Security and Cooperation in Europe (OSCE) on online safety which is being introduced to its 57-member nations.

YOUR PARTNERSHIP is forcing Big Tech and social media platforms to **make these changes!**

A PARENT'S CRY FOR HELP

"I am physically, mentally, and emotionally exhausted from dealing with tech and my 12-yearold daughter.

I'm on week 2.5 of parent patrolling with Bark [third-party parental controls] and I'm just exhausted by what this wonderful app has brought to light. It prevented a cybersex incident 2-ish weeks ago because I was able to intervene in time.

Luckily, I'm self-employed so I've been able to neglect my work for the most part over the last two and a half weeks, but I can't continue like this.

How are other parents supposed to do this when they aren't self-employed and can't ignore their work for two and a half weeks to focus solely on setting up and managing controls for their children's phones and devices? This is truly insane and ridiculous. How have we let all of this get to where it is and be SO bad that it takes days of our lives to try to put it into SAFE order?

What am I doing wrong? I don't want to be a parent anymore. I don't know how to do this.

I'm about ready to walk to Washington, DC to beg and plead for regulation on technology for children under the age of 18. This is insane." IN A PUBLIC STATEMENT, SNAPCHAT THANKED NCOSE FOR INFLUENCING THEIR IMPROVEMENTS, STATING:

NCOSE hears the plea of parents-and we are pursuing real solutions!

By holding tech companies accountable to prioritizing safety, we are creating a world where parents can rest easy, knowing their kids are safe online. Right now, as illustrated by this graphic, it is the opposite, as children and parents have to police the internet with no help. But we can invert this triangle, and relieve children and parents of this burden – and placing it where it belongs – on the tech industry!



We are creating a world where ALL children are automatically protected, even if they don't have the privilege of highly involved, highly available parents who can afford to dedicate exorbitant amounts of time to monitoring their online behavior.

Thanks to you, we are getting closer and closer to such a world.

CORE OBJECTIVE END SEX TRAFFICKING AND PROSTITUTION BY HALTING SEX BUYERS

It's a simple equation: No buyers = No demand = No profit. By placing the legal, financial, and reputational penalties for purchasing sex on the buyer, instead of the victim, we can greatly reduce the demand for exploiting human beings for profit. With no demand, there will be no need to have a "supply" of victims of sexual abuse and exploitation. With no profit, there will be no motivation for pimps and sex traffickers to exploit people.

VICTORIES AND HIGHLIGHTS:

• Efforts to fully decriminalize prostitution, or to legalize sex buying, pimping, and brothel-keeping have failed across America! **Together**, we continue to stop the wave of efforts to explode the commercial sex industry.

• Maine became the first state in the U.S. to adopt the "Nordic model," increasing penalties for sex buyers and sex traffickers, while providing exist services and support for survivors. This is only the beginning of a shift in the US!! • California passed a high-profile bill, SB14, that **classifies child sex trafficking as a serious felony,** allowing state authorities to pursue life sentences under its "three strikes" law.

• We are challenging demand through two high-profile lawsuits! We are suing the state of Nevada and several of its notorious legal brothels and we represent survivors of the notorious Tate Brothers' pornography and sex trafficking empire.

Because of YOUR partnership, life is becoming more difficult for sex buyers and sex traffickers, while becoming SAFER for those who have been victimized by sexual exploitation.

HOW A VICTIM BECAME AN ADVOCATE FOR A VICTORY

Jane* was 15 years-old and struggling to support her son. One day, she was at a restaurant, talking with a friend about her financial difficulties and how much she loved her son. Some men approached her and offered to help her make money, instructing her to meet them at a certain apartment.

Jane* went ... and was sex trafficked.

The men forced her to perform sexual acts, saying they would take away her son if she refused.

Now, Jane* is a powerful advocate, speaking out against sexual exploitation. When the Maine Senate passed LD 1435, she said:

"Today, I am so proud to live here in Maine ... This legislation is firmly rooted in anti-trafficking and acknowledges that arresting and revictimizing people for their own exploitation is not the solution. Rather, holding the exploiters and abusers accountable is the answer."

OUR MISSION


