## Dear Members of Congress:

The undersigned organizations, including survivors of child exploitation and sex trafficking, endorse the EARN IT Act (Eliminating Abusive and Rampant Neglect of Interactive Technologies Act) of 2023 as an essential remedy to the rampant online circulation of child sexual abuse material (CSAM, legally referred to as child pornography).

The National Center for Missing and Exploited Children's (NCMEC) CyberTipline receives reports about multiple forms of online child sexual exploitation. CSAM comprises the largest reporting category. Over 99.5% of the reports received by the CyberTipline in 2022 involved incidents of suspected CSAM; there were 31.9 MILLION reports of child pornography in 2022, a 47% increase from 2020. These are astronomical numbers—and they represent real children.

CSAM is documentation of a crime. Victims suffer gross physical and psychological harm at the hands of offenders and continue to suffer as their abuse is endlessly shared and circulated online. It is time to confront and restrict rampant sexual abuse occurring on digital platforms.

The EARN IT Act **repeals near blanket immunity** from liability enjoyed by interactive computer service, or digital, companies under judicial interpretations of Section 230 of the Communications Decency Act of 1996. **Victims will finally have access to justice** because EARN IT will allow them to use federal civil and state criminal and civil law to seek redress for harm suffered by digital negligence.

Despite federal law requiring that NCMEC be alerted regarding CSAM, some of the biggest tech giants ignore this obligation. Bottom line: content moderation resources will never be enough to eliminate the illegal and harmful activity facilitated by digital platforms. For this reason, Congress needs to instill protections that will keep our children and others from being exploited in exchange for advertising profits.

Finally, EARN IT updates existing federal statutes to replace "child pornography" with "child sexual abuse material" (CSAM). "Child pornography" undermines the seriousness of the abuse, while CSAM will accurately convey the type of content and remove the stigma and shame victims carry throughout life.

Big Tech's lobbyists insist the EARN IT Act undermines privacy, free speech, and human rights. On the contrary: EARN IT allows victims the possibility of restoring their privacy, recognizes CSAM as a serious crime, and protects the rights of children online. Liability is a bedrock principle in American law that should apply to digital platforms as it does to other marketplace actors.

We urge Congress to pass the EARN IT Act.
